Re: Cosmetic Fragrance Allergens

Product: 461, delta-DECALACTONE, LOT # 2021270-0015

Quantitative analysis has been performed for delta-DECALACTONE (BRI 461) using EN 16274:2021 (SCCS/1459/11) for 64 fragrance allergens with specifications of 20mg/kg(ppm) for each named allergen.

The material itself has no correlation or relation to the listed 64 fragrance allergens defined in the table below.
