# 4. FIRST AID MEASURES

#### Description of first aid measures

General advice Show this safety data sheet to the doctor in attendance. Immediate medical attention is

**Inhalation** Aspiration into lungs can produce severe lung damage. If breathing has stopped, give

Skin contact Wash off immediately with soap and plenty of water while removing all contaminated

allergic reactions see a physician.

non-combustible material and transfer to containers for later disposal.
