#### 4. FIRST-AID MEASURES

#### Methods and materials for containment and cleaning up

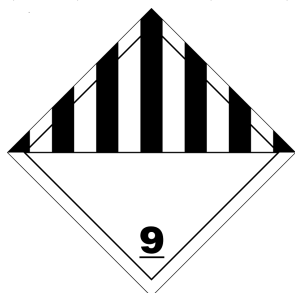
