Notable Exposure IRRITATION
symptoms:

Section 6: Accidental Release Measures

Personal precautions, Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all **protective equipment** ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate **and procedures:** protective equipment and clothing during clean-up. Avoid breathing vapors. Ventilate area if easy to do so.
