### 6. ACCIDENTAL RELEASE MEASURES

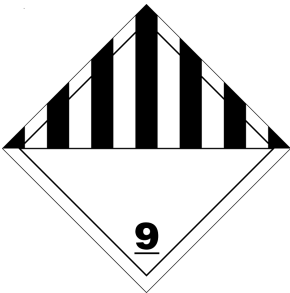

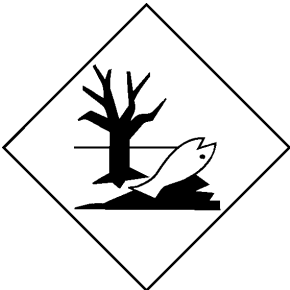
